## Public Works Project of the Year Award

### Purpose

The APWA Public Works Project of the Year Award was established to promote excellence in the management and administration of public works projects by recognizing the alliance between the managing agency, the consultant/architect/engineer, and the contractor who, working together, complete public works projects.

#### Awards will be given in the following five Categories:

- Building/Structures • Transportation • Environmental
  - Disaster or Emergency Construction/Repair • Historical Restoration/Preservation
1. Projects less than \$5 million (construction cost)
  2. \$5 million, but less than \$25 million (construction cost)
  3. \$25 Million-\$75Million (construction cost)
  4. More than \$75 Million

### Eligibility

Public works is defined as the physical structures and facilities that are developed, owned, and maintained by public agencies to house governmental functions and provide water, power, waste disposal, transportation, and similar public services in accordance with established public policy.

To be eligible for nomination, a project must have been “substantially completed” and available for public and/or agency use within two calendar years prior to nomination. If a project has multiple phases or segments, then “substantially completed” will be construed as that point when the final phase or segment is 90% completed and available for public and/or agency use.

### Selection

#### Criteria to be used in the selection process include:

1. Strategies and tactics for meeting project design/construction schedules, budgets, and communication processes.
2. Perceived Need for Community
3. Creative use of municipal resources, equipment, labor, funds that produced measurable benefits to the community.
4. Safety performance and demonstrated awareness of the need for a good overall safety program during construction.
5. Community relations as evidenced by efforts to minimize public inconvenience due to construction, safety precautions to protect public lives and property, provision of observation areas, guided tours, or other means of improving relations between the agency and the public.
6. Demonstrated awareness for the need to protect the environment during the project. This includes any special considerations given to particular environmental concerns raised during the course of the project.
7. Unusual accomplishments under adverse conditions including, but not limited to age or condition of the facility, adverse weather, soil, or other site conditions over which there is no control.
8. Additional conditions deemed of importance to the public works agency, such as exceptional efforts to maintain quality control and, if value engineering is used, construction innovations as evidenced by time and/or money-saving techniques developed and/or successfully utilized.
9. Use of sustainable infrastructure rating system or the equivalent (such as the Envision rating system) to ensure project is sustainable.

### Process

Nominations of projects can be made by the managing public agency, engineer of record, construction manager, or general contractor. The Judges review the nominations and select the award winner(s). Submittal Fee: \$50 per nomination.
